## CONTRACTOR'S NON-NEGOTIABLE AGREEMENT

United States Business Registration Inc, Located at 1310 Heather Ridge Blvd., Dunedin, FL 34698 and the Applicant shown on Page ONE

(1) approved by United States Business Registration Inc, enter into this Agreement ("Agreement") and agree to be bound by the contractual provisions contained herein. In consideration of the mutual promises contained in this agreement, United States Business Registration Inc and Contractor agree as follows:

1. **Acceptance:** Contractor has read and understands this Agreement. 2. **Termination:** This agreement can be canceled by the customer by sending an email to [billing@usbri.us](mailto:billing@usbri.us) within 48 hours of the acceptance of this agreement. The email must include the name of the business, business phone number, and the word cancel in the body of the email. After that time there will be a cancellation fee not to exceed the full amount of the purchase. The customer agrees not to stop pay on any types of payment including but not limited to Credit Cards, Checks, ACH, or Check Drafts. Any charges of a stop payment or dispute to any bank or payment processor will be in direct violation of this agreement and all charges associated with this action will be passed on to the customer, not limited to attorney fees and bank charges.
3. **Performance:** United States Business Registration Inc will provide to Contractor all items ("Materials") for the particular service package purchased by Contractor and is provided a user name and password to access and maintain Contractor's classification profile. 12. **Severability:** If any term or condition of this Agreement is held invalid or unenforceable to any extent or in any application, then such term or condition shall automatically, and without any further action, be reformed so as to retain the fullest extent of any restriction therein permitted by law and the remainder of the Agreement, except to such extent or in such application, shall not be affected thereby, and each and every remaining term and condition of this Agreement shall be valid and enforced to the fullest extent and in the broadest application permitted by law.
13. **Entire Agreement/Amendment:** This Agreement (including these Terms and Conditions), together with any specifications, instructions, drawings, samples, descriptions and designs delivered to Contractor by United States Business Registration Inc, constitutes the entire agreement between Contractor and United States Business Registration Inc.
